## COVID-19

# We are monitoring the spread of the virus and following the guidance of VFW National. As written in the latest National Orders...

"Pursuant to the authority under Section 618(a)(4), effective immediately and until rescinded, we ask that Posts, Districts and Departments, if possible and within the requirements of mandated State Declarations, make the attempt to elect officers. For such Posts, Districts or Departments that are not able to elect officers as a result of COVID-19, all current officers shall continue to function within their capabilities until new officers are elected. It is further stipulated that no Post, District or Department be sanctioned as result of the inability to properly function, as mandated by state or local government declarations, as a direct cause of COVID-19."

### **Department Convention Obligations**

The delegate strength of a Post will be one for every 30 members or fraction thereof in good standing as of March 31<sup>st</sup>. Each Post will pay \$10 for each delegate, based on voting strength, to the Department Convention, regardless of attendance. All registration fees so collected as above set forth, shall be placed in a Department Convention Fund by the Department Quartermaster and used and expended only as, and for expenses incurred and expenditures made in holding of an annual Department Convention each year.

Registration fee is due at the Department Convention. Posts not attending the convention should send dues to the Department Headquarters.
